BACKGROUND/OBJECTIVES:

A data review will be conducted by the Geology-Geophysics Section on the geophysical content of the Department of Energy (DOE) draft document entitled Seismic Reflection, Gravity, and Aeromagnetic Studies of Geologic Structure in the Gibson Dome Area, Southwestern Paradox Basin. The review will require a three (3) day meeting between NRC, DOE, and Woodward-Clyde staff (DOE consultant), October 16, 17, and 18, at their San Francisco offices. The Geology-Geophysics Section requests that a task order be issued to Weston Geophysical Corporation, based on Task 3 of the subject contract, to assist the NRC staff at the data review.

STATEMENT OF WORK AND DELIVEABLES:

Weston is requested to provide technical assistance from two (2) staff members in the assessment of the data base used in the production of the previously mentioned document. Technical assistance will come in the form of participation at the data review and the submission of a summary report. Emphasis should be placed on the data used to generate seismic lines 33 through 39 & 43, the gravity profiles, and areas of aeromagnetic anomalies contained within the document.

PERIOD OF PERFORMANCE:

Weston's presence at the meeting will be required Tuesday through Thursday, October 16 through 18, 1984. The data review will begin at 9:00AM on the 16th and concluding at 4:00PM on the 18th (a tentative schedule is attached to this enclosure).

NAME OF TECHNICAL CONTACT:

The NRC contact for all technical matters involving this particular task order shall be Ben Rice. Questions should be directed to him at (301) 427-4646.

REPORTING REQUIREMENTS:

The final product shall be in the form of a trip report (format details are identified in the contract Statement of Work under Deliverable Products). The report will summarize all data reviewed at the meeting and comment on the quality of acquisition, processing, and interpretation, and the appropriateness of the data as it applies to the subject document.

ESTIMATED LEVEL OF EFFORT:

The Geology-Geophysics Section has estimated that Weston would require a total of 2½ man-weeks to complete this task; 8 man-days for the two staff member's presence at the meeting and an additional 5 man-days to produce the required trip report.

RESPONSE DATE FOR RECEIPT OF PROPOSAL:

Based on present time constraints, the requested response date for this task order proposal is Friday, October 12, 1984.
