Dear Dr. Ibrahim:

During the month of June, Weston had general discussions concerning present activities and potential reviews. Mr. Levine submitted his Trip Report for May 23, 1985, Basalt Waste Isolation Project [BWIP], DOE/NRC Meeting on seismic survey and other geophysical work, Silver Spring, Maryland on June 4, 1985. This completes Task Order 010. Our billing is being held pending receipt of Letter of Authorization for this Task Order.

Weston received a request to submit a cost estimate for Task Order 011 on June 20, 1985. The proposal for this Task Order was sent by Federal Express on June 24, 1985. In order to meet the anticipated deadline, it is urgent that we receive approval to start this task.

Mr. Vincent J. Murphy met with Dr. Ibrahim, Mr. Malcolm Knapp and Mr. John Trapp in Silver Springs, Maryland on June 13, 1985, to discuss possible upcoming Task Orders and the contract in general. Also, we were advised of a Draft Agenda for TBEG Data Review from August 5 through 9, 1985, in Austin City Limits.
