Dear Mr. Knight:

The purpose of this letter is to request the status of several recent NRC letters to you providing comments and requests for additional information (RAI) on the DOE Headquarters and Project Office QA plans for high-level radioactive waste repositories. The specific QA plans and dates of the NRC RAI's are as follows:

As we indicated in our October 11, 1985 letter to William J. Purcell of DOE, we also intend to review and comment on the QA plans of the prime contractors after DOE approval of the plans. Formal approval letter and plans have not yet been submitted to our staff.

It our understanding that the first Site Characterization Plan (SCP) is scheduled for submittal to NRC for September 1987. Consequently, in order to

avoid schedule delays and conflicts between the evaluation of SCP's and QA plans, we believe it is critical that outstanding QA plan issues be resolved prior to submittal of SCP's. The meeting now scheduled for August 17, 1987, to discuss the OGR QA Plan, should be beneficial but additional meetings between DOE Headquarters, the DOE Project Office, DOE contractors and NRC staff on the other plans are also needed to develop an understanding of NRC RAI's and thereby expedite the means for the comment resolution process for the QA plan issues.
