

Executive Team (ET) Questions:

- **How many former LPDRs are there that still contain NRC information?**

**There are currently 72 libraries that house NRC's microfiche collections in 34 states.** These include 54 former Local Public Document Rooms (LPDRs) that have voluntarily chosen to keep the NRC microfiche collections as well as 18 additional libraries that assumed responsibility for the collections. Of the 72 libraries, 28 are public, county, or college libraries and the remaining 44 are participants in the United States Government Printing Office /Federal Depository Library Program (GPO/FDLP). **There are 24 selective and 20 regional depository libraries in the United States.** These 24 selective libraries not only have the microfiche collection they may also have paper copies of certain categories of documents. The 20 regional depositories would have all NRC documents that went through the depository system. See Attachment A for a detailed list of all libraries holding NRC collections.

In addition to the microfiche collections at these 72 locations there are some libraries that have paper collections and indexes that are site-specific. The indexes are either accession lists provided by the NRC or on microfiche (*NUREG-540 Title List of Documents Made Publicly Available*, published monthly and compiled annually. (Citations to this index are scattered throughout the 48X microfiche collection. This finding tool covers the collection in its entirety.)

(N.B. NRC documents have been widely disseminated over the years in a variety of ways. In addition to the LPDRs, there have been other avenues to legitimately purchase NRC information. NTIS historically has sold copies of NRC documents to the public produced from microfiche. The Government Printing Office has also sold copies of NRC documents. In addition, at least two companies have purchased the NRC microfiche collection from the NRC document reproduction contractor.)

- **What type of relationship, if any, do we have with them if we decide to pull back certain documents?**

**Those 28 libraries that are not part of GPO/Federal Depository Library Program (FDLP) have no formal relationship with the NRC.** The microfiche collections were officially abandoned by the NRC. They are now property of the host library. The NRC has asked that if at any time they decide to cease keeping the collection, they contact the GPO/FDLP Regional Library serving their area so that action can be taken to relocate the collection to another library. In those 44 selective and full depository libraries, the microfiche collections were officially abandoned to the Government Printing Office (GPO) and remain U.S. Government property under the GPO/FDLP as a depository item.

The depository libraries are under GPO, a federal entity. We provide our documents to GPO to disseminate them. We will need to further explore NRC's relationship to GPO with regard to NRC documents since they become part of the GPO libraries' permanent collections.
