Please publish NUREG-1752, "Assessment of Modernization and Integration of BWR Components and Spatial Kinetics in the TRAC-M, Version 3690, Code." This document has been reviewed against: 1) the draft criteria, presently at the Commission for approval, for discretionary release of information to the public, and 2) factors for staff consideration provided by the EDO in a memorandum dated December 5, 2001. Based on this sensitivity review it has been determined that the content of NUREG-1752 is benign and contains no sensitive information that can be misused by those with malevolent intentions toward NRC-regulated facilities and activities. Publication of NUREG-1752, "Assessment of Modernization and Integration of BWR Components and Spatial Kinetics in the TRAC-M, Version 3690, Code", has been halted because of new Commission criteria. Please forward this E-Mail to Mabel Lee and state that the document has been reviewed against the Commission's draft criteria and the criteria in Traver's memo and that the document has been found to be benign and nonsensitive. Request that OCIO print and distribute the document.

I have reviewed the document against the Commission's draft criteria in Travers' memo of December 5, 2001, and make following finding:

The content of this report is benign and contains no sensitive information that can be used by those malevolent intentions. The document does not contain information covered by six criteria, i.e.,

1. No plant specific information that might be used to exploit site specific features including equipment and specific facility locations.
2. No specific locations of the facility site.
3. No information of physical barriers and vulnerabilities and potential weaknesses.
4. No construction details of facilities.
5. No information on defeat or breach of barriers
6. No information on quantities of radioactive material present or authorized.

The NUREG report contains information on assessment of the TRAC-M computer code. This information is not specific to any plant.
