By letter dated April 21, 2003, the Westinghouse Owners Group (WOG) submitted for NRC staff review Topical Report (TR) WCAP-15830-P, Rev. 00, "Staggered Integrated ESF Testing." It has since requested, in a conference call on September 15, 2003, that consistent with the NRC Office of Nuclear Reactor Regulation Instruction LIC-500, "Processing Requests for Reviews of Topical Reports," that the NRC provide an estimate of the review hours, as well as target dates for any requests for additional information (RAIs) and for completion of the safety evaluation (SE) for the TR.

The NRC staff has performed an acceptance review of WCAP-15830-P, Rev. 00. We have found that the material presented is complete enough to begin a review. The staff expects to issue RAIs by October 15, 2003, and complete its review by March 15, 2004. It is estimated that the review will require approximately 160 staff hours.

Section 170.21 of Title 10 of the *Code of Federal Regulations* requires that TRs are subject to fees based on the full cost of the review. A request for fee waiver for this TR has been denied by the staff. The WOG was notified of the denial by letter dated July 21, 2003. By letter dated September 12, 2003, the WOG authorized NRC staff review of the TR. Therefore, staff hours will be billed in accordance with the referenced regulation. To enable us to complete this review on schedule, close and frequent communications between our technical staffs will be required.
