Payment of this amount would result in a holdback of \$900.00.

7. PPA has served a copy of this Application (without Exhibits) on the Special Notice List in this case.

- 8. Pursuant to this Court's "SECOND AMENDED ORDER ESTABLISHING INTERIM FEE APPLICATION AND EXPENSE REIMBURSEMENT PROCEDURE" which was entered on or about March 18, 2002, the Debtor is authorized to make the payment requested herein without a further hearing or order of this Court unless an objection to this Application is filed with the Court by the Debtor or the United States Trustee and served by the fifteenth day of the month following the service of this Application. If such an objection is filed, Debtor is authorized to pay the amounts, if any, not subject to the objection. This Cover Sheet Application was mailed by first class mail, postage prepaid, on or about September 30, 2003.
- 9. The interim compensation sought in this Application is on account and is not final. Upon the conclusion of this case, PPA will seek fees and reimbursement of the expenses incurred for the totality of the services rendered in the case. Any interim fees or reimbursement of expenses approved by this Court and received by PPA will be credited against such final fees and expenses as may be allowed by this Court.
