INTRODUCTION

- **Proceedings of PA PUC**
 - **1987 Complainant requests full-time independent inspector and consultant to review decommissioning plan under county commissioners.**
 - **Feb 95 GPU Nuclear proposes part-time independent inspector under contract with Penn State Univ.**

INSPECTOR CONTRACT

- **Jan 96 – Jun 98 contract w/PSU**
- **Jul 98 – Dec 00 extension w/PSU**
- **Jan 01 – Dec 02 extension w/PSU**
- **Jul 02 – present, direct contract w/inspector**

INSPECTOR

- **Conduct random unannounced inspections of the site (≥ 3 /mo).**
- **Review and observe work, plans, procedures, records.**
- **Provide technical information to community (public meetings, 800 number).**

INSPECTOR

- **Train persons to do monitoring.**
- **Invited to Readiness Review meetings**
- **Provide written quarterly reports and final report to Bedford County Commissioners, SCTF and GPU Nuclear.**

GPU NUCLEAR

- **Provide draft copies of decommissioning plan.**
- **Provide work schedule.**
- **Provide unrestricted access to records and provide copy.**
- **Provide unrestricted access to the Saxton facility.**

PROBLEM RESOLUTION

- **Notify Saxton Site Supervisor**
- **If not resolved, notify:**
 - **Saxton Program Director**
 - **Bedford County Commissioners**
 - **Public Utilities Commission**

 - **Long-term interaction of the NRC project manager and NRC inspector with the Saxton Citizens Task Force.**



LTP Review Duration Very Long

- **Greater Than Two Year Approval Process**
 - Pre-Application Meetings and Adequacy Review Did Not Uncover Concerns
 - Extensive Information Requests to Resolve Staff Site Characterization and Dose Modeling Concerns
- **Second Review Team Improved Performance**
 - Weekly Conference Calls Resolved Issues
 - Informal Review of Proposed Revisions Shortened Approval Time
- **ASLB Process Duration Also Greater Than 2.5 Years**
- **Improvements Being Implemented for Yankee Rowe LTP**

 - Remediation Standard Regulations for Groundwater and Soil
- **Environmental Protection Agency**
 - EPA – NRC Memorandum of Understanding
 - RCRA Corrective Action Program
