The NRC staff has not identified any open or confirmatory items in its review. However, in accordance with the schedule for completing the review of the VCSNS LRA, the applicant is requested to review the enclosed SER, verify its accuracy, and provide comments by December 29, 2003. The NRC staff plans to review the current content and format of the SER to further improve the SER while incorporating the applicant's responses. A complete, revised SER will then be issued by March 11, 2004.
