The purpose of this modification is to obligate FY'03 funds in the amount of \$15,000.00, thereby increasing the obligated amount of the contract from \$765,000.00 to \$780,000.00.

Accordingly, the following changes are hereby made:

Under Subsection B.2 - CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE, Paragraphs c and d are deleted in their entirety and substituted in lieu thereof the following:

- (c) The amount currently obligated by the Government with respect to this contract is \$780,000.00, of which the sum of \$721,888.00 represents the estimated reimbursable costs, and of which \$58,112.00 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through October 31, 2003."
