The purpose of this modification is to (1) revise the Statement of Work contained in Section C; (2) revise the total estimated cost shown in Section B.3; and (3) obligate additional funds in the amount of \$12,326 in order to fully fund the contract. Accordingly, the following changes are hereby made:

1. Section B.3. CONSIDERATION AND OBLIGATION –COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) , paragraphs (a) and (c) are hereby deleted and substituted with the following:

*(a) The total estimated cost to the Government for full performance of this contract is \$491,880, of which the sum of \$462,072 represents the estimated reimbursable costs, and of which \$29,808 represents the fixed fee.

*(c) The amount currently obligated by the Government with respect to this contract is \$491,880, of which the sum of \$462,072 represents the estimated reimbursable costs, and of which \$29,808 represents the fixed fee.

2. Section C, DESCRIPTION/SPECIFICATIONS/STATEMENT OF WORK, is hereby modified to replace the existing Statement of Work with the three (3) pages attached to this modification.

A summary of obligations for this contract, from award through the date of this action, is provided below:

This modification obligates FY03 funds in the amount of \$12,326.00.
