The purpose of this mod is to exercise option period 2 and adjust prices per the SCA wage determination. Accordingly, Option Period 2 is exercised at the prices set forth on the attached OF 336. In addition, Section C.15 entitled Duration of Contract is added to this contract and reads as follows, "The contract commenced on November 1, 2001 and will expire on November 30, 2004." The total contract price is increased by \$356,501.40 from \$759,286.75 to \$1,115,788.15. The attached SCA wage determination is effective for this next option year. The new prices established in this modification include adjustments made based on the new SCA wage determination.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
