SUBJECT: FILING NRC FORM 241 FOR CALENDAR YEAR 2004

The U.S. Nuclear Regulatory Commission received your calendar year 2003 clarification to NRC Form 241. Please note that the staff updated the dates requested for calendar year 2003; however, you must file for reciprocity annually, to continue to work NRC jurisdiction for calendar year 2004.

Each calendar year Agreement State licensees (licensees) seeking to conduct activities under reciprocity in areas of exclusive Federal jurisdiction within Agreement States, non-Agreement States, or in offshore waters (reciprocity activities), must submit NRC Form 241, "Report of Proposed Activities in Non-Agreement States, Areas of Exclusive Federal Jurisdiction, or Offshore Waters"; 4 copies of the Agreement State specific license; and the fee specified in fee Category 16, 10 CFR 170.31 (currently \$1500). This filing must be made to the NRC for the first time in any calendar year that such activities are to occur. NRC Form 241 may be found at www.hsr.d.ornl.gov/nrc/special/fr241.pdf. NRC must receive this filing at least 3 days before the licensee engages in activities permitted under the General License established by 10 CFR 150.20.

Important information on working in NRC jurisdiction and guidelines to follow in filing NRC Form 241 may be found in NUREG-1556, Volume 19, "Guidance For Agreement State Licensees About NRC Form 241 'Report of Proposed Activities in Non-Agreement States, Areas of Exclusive Federal Jurisdiction, or Offshore Waters' and Guidance for NRC Licensees Proposing to Work in Agreement State Jurisdiction (Reciprocity)." It is expected that licensees will review this information, as well as the regulations cited in 10 CFR 150.20(b), to ensure that the radiation safety program is in compliance with NRC regulations prior to conducting activities under reciprocity.
