This confirms the verbal authorizations provided to you on July 19, 2003, with a temporary ceiling of \$2,000.00 and August 18, 2003, with a temporary ceiling of \$20,000.00.

In accordance with the Section G.5, Task Order Procedures, of the subject contract, this letter definitizes Task Order No.006. This effort shall be performed in accordance with the enclosed Statement of Work.

Task Order No. 006 shall be in effect from July 19, 2003, through February 23, 2004, with a cost ceiling of \$113,515.95, which is inclusive of the temporary ceilings authorized on July 19, 2003, of \$2,000.00 and August 18, 2003, of \$20,000.00. The amount of \$106,016.59 represents the total estimated reimbursable costs, the amount of \$78.20 represents the facilities capital cost of money, and the amount of \$7,421.16 represents the fixed fee.


