18 FOR ALLOWANCE AND PAYMENT OF INTERIM COMPENSATION
19 AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD SEPTEMBER 1-30, 2003

20 Steefel, Levitt & Weiss (the "Firm") respectfully submits its Cover Sheet Application (the
21 "Application") for Allowance and Payment of Interim Compensation and Reimbursement of
22 Expenses for the Period September 1-30, 2003 (the "Application Period"). In support of the
23 Application, the Firm respectfully represents as follows:

24 1. The Firm is Special Counsel to the debtor and debtor-in-possession in the above-
25 referenced bankruptcy case (the "Debtor"). The Firm hereby applies to the Court for allowance
26 and payment of interim compensation for services rendered and reimbursement of expenses
27 incurred during the Application Period.

2. The Firm billed a total of \$41,723.90 in fees and expenses during the Application Period. The total fees represent 154.19 hours expended during the Application Period. These fees and expenses break down as follows:

3. Accordingly, the Firm seeks allowance of interim compensation in the total amount of \$35,639.12 at this time. This total is comprised as follows: \$34,480.44 (85% of the fees for services rendered)¹ plus \$1,158.68 (100% of the expenses incurred).

Pursuant to this Court's "SECOND AMENDED ORDER ESTABLISHING INTERIM FEE APPLICATION AND EXPENSE REIMBURSEMENT PROCEDURE (Revised March, 2002)" which was entered on or about March 18, 2002, the Debtor is authorized to make the payment requested herein without a further hearing or order of this Court unless an objection to this Application is filed with the Court by the Debtor, the Committee or the United States Trustee and served by the fifteenth day of the month following the service of this Application. If such an objection is filed, Debtor is authorized to pay the amounts, if any, not subject to the objection. The Firm is informed and believes that this Cover Sheet Application will be mailed by first class mail, postage prepaid, on or about October 13, 2003.

9. The interim compensation and reimbursement of expenses sought in this Application is on account and is not final. Upon the conclusion of this case, the Firm will seek fees and reimbursement of the expenses incurred for the totality of the services rendered in the case. Any interim fees or reimbursement of expenses approved by this Court and received by the Firm (along with the Firm's retainer) will be credited against such final fees and expenses as may be allowed by this Court.




