SUBJECT: TRANSMITTAL OF SUMMARY FOR U.S. NUCLEAR REGULATORY COMMISSION (NRC)-
U.S. DEPARTMENT OF ENERGY (DOE) TECHNICAL EXCHANGE ON THE STATUS OF
DOE'S DATA MANAGEMENT PROGRAM

The purpose of this letter is to transmit the summary for the July 30, 1991 NRC-DOE technical exchange on the status of DOE's data management program. DOE presented its current plans for management and control of the technical data on the Yucca Mountain, Nevada proposed high-level waste repository site. DOE presentations included an overview of its Technical Data Management System, an explanation of its Automated Technical Data Tracking System, discussions of specific technical data base initiatives, an update of the status of the Reference Information Base, and a demonstration of the Geographic Information System (GIS). NRC expressed particular interest in mechanisms by which its access to the DOE data base will be facilitated. A representative of the State of Nevada also attended this interaction.
