I understand that the Southern Nuclear Operating Company, a subsidiary of the Southern Company, has filed an application to renew the Joseph M. Farley Nuclear Plant's license for an additional 20 years for Farley Units 1 and 2.

Plant Farley provides jobs for 900 citizens of the Wiregrass area; and \$7 million in tax revenue. The employees are strong servants of our community and our schools. They participate in the "Spirit of Service Day", which is held annually to help better our community through special projects, as well as many other community activities. 

WHEREAS, Plant Farley provides jobs for some 900 citizens of the Wiregrass; and


WHEREAS, these employees are strong servants of our community and our schools; and are faithful stewards of the environment; and


WHEREAS, Plant Farley provides extensive support for the quality of life and the infrastructure needs in the Wiregrass as the County's largest tax payer.







