The purpose of this modification is to 1) exercise the optional requirement for 13 additional Kyocera Mita Model No. KM6330 copiers in accordance with FAR Clause 52.217-7 and 2) increase the contract ceiling amount by \$236,340.00, from \$779,387.00 to \$1,015,727.00. Accordingly, the contract is hereby modified as follows:

1. The contractor shall deliver thirteen digital copier model KM6330 on a 60-Month Lease to Purchase basis (includes 90-day warranty period) at the monthly lease amount of \$303.00 for 60 months for thirteen copiers. The contractor shall remove thirteen KODAK Model 2085 copiers for the trade-in value of \$3,160 .00 each.
2. The ceiling amount of this delivery order is increased by \$236,340.00 (13 copiers X \$303.00 X 60 months) from \$779,387.00 to \$1,015,727.00. This modification does not obligate any funds. The order will be funded upon availability of fiscal year funding.

A summary of obligations for this contract from the date of award through the date of this action is provided below:
