This letter is to inform you that a resident inspector counterpart meeting will be held on December 2-4, 2003, in the U.S. Nuclear Regulatory Commission (NRC) Region IV office in Arlington, Texas.

During the NRC/CNSNS bilateral meeting held in Texas in May 2003, our two agencies agreed upon pursuing cooperation of a number of topics listed in a Matrix of Technical Topics of Cooperation.
