come to a melt down in March of 2002.

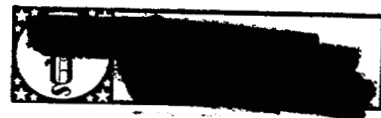
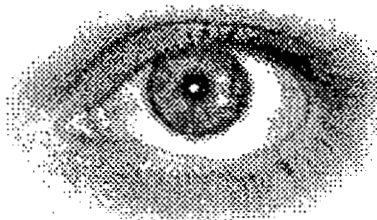

Dear Mr. Dyer,

I was once a resident of [Redacted], Ohio attending Terra Technical College and working in that area. I was driving to visit a classmate, who also lived in the area, and got lost. I realized my error when I was met with a gated fence and a bigger-than-life silhouette of the Davis-Besse nuclear plant several hundred yards in front of me. I literally had to remind myself to breathe as I had frozen in my spot. I remember a fear overcoming me & a desire to get away from there as soon as I could. I turned around and soon found my originally intended destination. I was shaken for quite a while... that was close to 22~~4~~ years ago... and it still bothers me to think of this memory. I am now a mother of 3 young children I fortunately no longer live within the 25 mile radius of the plant. ~~then~~ 1982 estimated figures (based on a Davis-Besse meltdown) performed by the NRC, and shared with me by Ohio citizen action information are certainly alarming. First Energy is a very well known company that really ought to put some of

their enormous finances into some major Davis-
Besse maintenance!!! there are thousands of
~~thousands of~~ lives at stake! i worked for a graphic arts
company that produced paint samples and the company
was closed; the building leveled & then based on many
materials which contaminated the grounds... the land
had to sit for at least 5 yrs before it was then
developed into a shopping strip mall. as far as i'm
concerned, Davis-Besse can forever remain closed.
Vacate, level & let it sit for the weeds & fields to
grow around it's huge filled in hole!! Knowing
the rural grounds around the Davis-Besse facility,
i don't even like the thought of buying produce that
may have been grown from around there. my
family & i go to Sandusky for the amusement park
& vacationing every summer and i would never
miss seeing the Davis-Besse silhouette on the horizon.

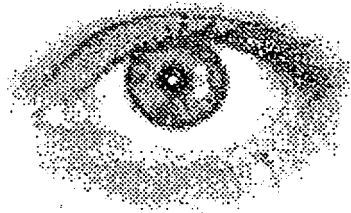

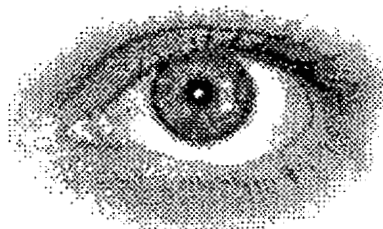

American worker, put their families

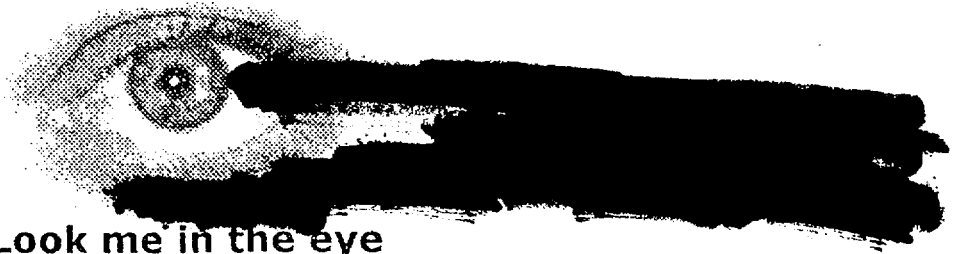

We have lived in the shadow of Davis-Besse since it was built. We have followed the shenanigans of its owners from the beginning of construction until now including the two near meltdowns and various other "incidents". Each event was followed by a promise to operate the plant safely. All these statements regarding safer operation were lies. Nothing changed and the danger to us all is as strong today as it ever was. As you know, on March 6, 2002, there was a hole discovered and Boric acid leaked through cracked pipes, leaving only three eighths of an inch of stainless steel cladding to seal the reactor. This could have lead to a meltdown, had the cooling system not have worked. There have been two such incidents in the past, where the public has come close to being exposed to deadly nuclear material.

My family has donated to help put out the word that the plant should not come on line, and if you allow this, we are willing to do whatever it takes to get this plant shut down, as it should be.
