The purpose of this modification is to: 1) Change the Contracting Officer's Technical Representative (COTR) assigned to the delivery order, 2) Exercise Optional Tasks 2 and 3 in the Statement of Work; and 3) Incorporate within scope changes to Optional Tasks 2 and 3, in accordance with the Contractor's proposals dated September 9, 2003; 4) Increase the estimated ceiling amount for Task 2 by \$58,654.96, from \$955,640.14 to \$414,295.10, 5) Decrease the estimated ceiling amount for Task 3 by \$58,680.86, from \$1,006,778.64 to \$948,117.78, 6) Increase the ceiling amount of the delivery order by \$1,362,412.88, from \$1,464,213.45 to \$2,826,626.33, and increase the obligated amount in the delivery order by \$448,000.00, from \$1,464,213.45 to \$1,910,213.45. Accordingly, the delivery order is hereby modified:

1. Section D.8, Project Officer, first paragraph, is deleted in its entirety and substituted with the following in lieu thereof:

2. Section D.10, Consideration and Obligation, is deleted in its entirety and substituted with the following in lieu thereof:

"The total estimated amount (ceiling) of this order is \$2,826,626.33. The total estimated amount for Task 1 is \$1,464,213.45. The total estimated amount for Optional Task 2 is \$414,295.10. The total estimated amount for Optional Task 3 is \$948,117.78. The Government hereby exercises Optional Tasks 2 and 3.

The amount presently obligated with respect to this order is \$1,910,213.45. The Contracting Officer may increase this amount from time to time by unilateral modification to the order. The obligated amount shall, at no time, exceed the order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder equals the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer increases the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

It is estimated the amount currently allotted will cover performance of the effort through April 30, 2004."
