


This Modification No. 4 accomplishes the following:

1. corrects the contract ceiling amount reflected in Modification No. 3 from \$142,329.00 to \$152,965.00.
2. as a result of a June 18, 2003 meeting held in NRC headquarters between NRC and BRMA, and BMRA's email dated 9/23/2003:
 - (a) decreases the number of meetings under Section B. CONTINUATION BLOCK, BASE YEAR, item 9., "Provide expert in PBSC...", from a Quantity of 20 to 1;
 - (b) adds item 9., "Provide expert in PBSC...", under Section B. CONTINUATION BLOCK, for all of the OPTION YEARS in the following estimated quantities of meetings: OPTION YEAR ONE Qty. 1, OPTION YEAR TWO - Qty. 5, OPTION YEAR THREE - Qty. 5, OPTION YEAR FOUR - Qty. 6, and the associated unit prices, in accordance with BMRA's email cost proposal dated 6/17/2003;
 - (c) revises Section B.8, PBSC SUPPORT SERVICES, to clarify the wording in subsections A. and B., and change the delivery date of the draft guidebook in subsection B.
3. exercises OPTION YEAR TWO of this contract, thereby extending the period of performance of this contract from October 1, 2001 through September 30, 2004, and increasing the contract ceiling amount to \$193,472.25.
4. provides incremental funding in the amount of \$50,000.00, thereby increasing the obligated amount of this contract from \$142,329.00 to \$192,329.00.
5. revises the GRAND TOTAL AMOUNT of the contract for the BASE AND OPTION YEARS under Section B., CONTINUATION BLOCK, to reflect changes through this modification from \$265,086.00 to \$307,374.25.
6. revises Section B.16, KEY PERSONNEL, to ADD Ms. Mary Ackerman.

2. Section B.8, PBSC SUPPORT SERVICES is deleted in its entirety and replaced as follows:

"A. The Contractor shall provide an expert on Performance-Based Service Contracting (PBSC) available, on an as needed basis, to meet with NRC staff (typically Contract Specialists and Project Managers for the proposed work) in order to provide hands-on assistance in developing PBSC statements of work (PBSC SOW), and other PBSC-related services. It is anticipated that approximately eighteen (18) PBSC SOW meetings will be required, each for eight hours duration. The contractor shall review draft PBSC SOWs submitted by the Contract Specialists in preparation for advising and assisting them in PBSC-related issues, and in the process of writing the PBSC SOW at NRC Headquarters. The Contractor shall provide a written recommendation to the Contracting Officer no later than 30 days after receipt of draft PBSC SOW's.

B. The Contractor shall develop a draft Guidebook based on the PBSC Meetings set forth in CLIN 009 of Option Year Two and subsequent meetings in Option Years Three and Four, if exercised. The Guidebook will contain no less than ten (10) NRC PBSC SOW's, and questions and answers resulting from the hands-on meetings. The Contractor shall submit a draft guidebook to the NRC PO for review and comment by NRC staff. The Contractor shall, within ten (10) working days of receipt of NRC comments, revise the Guidebook incorporating NRC's comments. The target date for completion of the Guidebook to the NRC PO is September 30, 2004. However, completion of the Guidebook is contingent upon NRC providing a minimum of ten (10) PBSC SOW's to the Contractor. The approved final guidebook shall be incorporated into the "Preparing Statements of Work" module."

3. Section B.16, KEY PERSONNEL, is revised to add Ms. Mary Ackerman as follows:

"B.16 KEY PERSONNEL

(a) The following individuals are considered to be essential to the successful performance of the work hereunder:



The contractor agrees that personnel may not be removed from the contract..."

4. Section B.17., CONSIDERATION AND OBLIGATION – DELIVERY ORDER (JUNE 1988), paragraphs "a." and "b." are revised to read as follows:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$193,472.25. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during

the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is \$192,329.00..."

5. Standard Form 1449, Block 26. TOTAL AWARD AMOUNT, as modified in Modification No. 2, is DELETED and REPLACED with the following:

"TOTAL AWARD AMOUNT: \$193,472.25."

6. Section C.5, 52.216.18 ORDERING (OCT 1995), paragraph (a) is revised as follows:

"(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from October 1, 2001 through September 30, 2004.

7. Section C.10, PERIOD OF PERFORMANCE, is DELETED in its entirety and REPLACED with the following:

"Section C.10, PERIOD OF PERFORMANCE

The period of performance of this contract is from October 1, 2001 through September 30, 2004. The term of this contract may be extended at the option of the Government an additional two years."

All other terms and conditions remain the same.
