This Modification No. 18 accomplishes the following:

1. Revises the estimated number of presentations under line item 4.a, to accommodate one (1) "Human Performance Investigation Process Training Course" to be held in Region II 9/25/03 at a total cost of \$7,530 for 25 students (\$4,890 for a nominal 15 students plus \$2,640 for ten (10) additional students @ \$264 each), in accordance with Conger and Elsea's email cost proposal dated 8/18/03. As a result, the estimated number of presentations under line item 4.a, "Human Performance Investigation Process Training Course" for Region II in FY2003 is increased from 0 to 1 with an increase in the firm fixed price by \$7,530 from \$0 to \$7,530.
2. Allows for the accommodation of (10) additional students for a "Two-Day Root Cause/Incident Investigation Refresher Training Course" to be held in Region II 9/23-24/03 at a total cost of \$15,240 for 25 students (\$9,960 for a nominal 15 students plus \$5,280 for ten (10) additional students @ \$528 each) . As a result, the firm fixed price under line item 5.a, "Two-Day Root Cause/Incident Investigation Refresher Training Course", for Region II in FY2003 is increased by \$5,280 from \$9,960 to \$15,240.
3. Reallocates \$11,398 of funds obligated under line item 5.a., "Two-Day Root Cause/Incident Investigation Refresher Training Course" from Region III to Region II in FY2003, as the course scheduled for 9/3-4/03 in Region III was canceled, per the Project Officer's email dated 8/22/03. These funds are being allocated to the "Two-Day Root Cause/Incident Investigation Refresher Training Course" to be held in Region II on 9/23-24/03. As a result, the estimated number of presentations under line item 5.a "Two-Day Root Cause/Incident Investigation Refresher Training Course" for Region III in FY2003 is reduced from 2 to 1 with a reduction in the firm fixed price by \$11,398 from \$22,796 to \$11,398.
4. Increases the contract ceiling amount of this contract by \$1,412 from \$874,141 to \$875,553.
5. Increases the obligated amount of this contract by \$11,372 from \$829,989 to \$841,361.

Accordingly, the following Section(s) of the contract are hereby modified:

1. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS, item 4.a., is revised to increase the "Estimated No. of Presentations" for Region II from 0 to 1, during FY2003, Accordingly, Section B.8 is revised to read as follows:
 - "4. a. HUMAN PERFORMANCE INVESTIGATION PROCESS TRAINING COURSE PRESENTATIONS (for Headquarters and at NRC regional offices - exact regional offices to be determined by NRC at later date. Unit prices shall include travel costs per course/per fiscal year as stated below):

2. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS, item 5.a., is revised to increase the number of "Estimated No. of Presentations" for Region II from 0 to 1, during FY2003, and decrease the "Estimated No. of Presentations" for Region III from 2 to 1, during FY2003. Accordingly, Section B.8 is revised to read as follows:

** Reduced by \$11,398.00, as the 2-day course scheduled for September 3-4, 2003 was canceled.

The unit prices shall include travel costs per course/per fiscal year. The unit price is for the accommodation of 15 participants per course. The cost per person beyond 15 participants is \$528. Execution of a unilateral contract modification is required of the Contracting Officer should the number of participants exceed 15."

3. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS is revised to increase the TOTAL ESTIMATED AMOUNT FOR ALL COURSES IN FY2003 by \$1,412 from \$283,940 to \$285,352, as a result of this modification.
4. Section B.8 SUPPLIES OF SERVICES AND PRICES/COSTS is revised to increase the GRAND TOTAL AMOUNT of the contract by \$1,412 from \$874,141 to \$875,553, as a result of this modification.
5. Section A.2 - Consideration and Obligation -- Delivery Orders (June 1988), first sentence of Subsection (2), as modified in Modification No. 3, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this contract is \$841,361."
