GROSS VISIT INFORMATION SHEET

FOREIGN NATIONALS MAY NOT BE INCLUDED IN GENERAL NTS VISITS SCHEDULED TO VISIT WEAPONS FACILITIES. THEY MAY BE INCLUDED ON VISITS TO RADIOACTIVE WASTE MANAGEMENT FACILITIES WITH SPECIFIC INDIVIDUAL APPROVAL (SEE ITEM III.4.a.)

I. SCHEDULE:

Nevada Test Site (NTS) operational requirements have priority over visits, which means a visit could be cancelled or postponed at the last minute.

II. REGULATIONS:

1. Visitors must remain under the control of a Department of Energy (DOE) escort at all times while on the NTS.
2. All visitors to the Test Site must be at least eighteen (18) years of age.
3. Visitors are not permitted to bring cameras, binoculars or telescopes onto the Test Site. News media may bring cameras provided the cameras remain in the possession of the DOE escort and photos may be taken only under the escort's supervision.
4. Soil, rock, or plant samples may not be removed from the NTS.

III. BADGING:

NOTE: Each visitor should be informed that:

1. The data requested under "a." below is required by the provisions of the Atomic Energy Act of 1954, as amended, and the Energy Reorganization Act of 1974.
2. The purpose of collecting the information is to enable preparation of security badges for access to the NTS.
3. The information may be routinely used by DOE security personnel, authorized Wackenhut Services, Inc., clerical and administrative personnel, security guards, and DOE security inspectors.

III. BADGING:

4. Provisions of the requested information is mandatory. Failure to provide sufficient information may prevent you from entering the NTS.
5. An alphabetical list of participants (last name first) and the required information which is listed below must be received by the Office of Public Affairs no later than ten days before the planned visit to the NTS for United States (U.S.) citizens; six weeks for foreign nationals.

- b. Foreign nationals' names may be deleted from the list of participants after it has been submitted to DOE, but no new names may be added. U.S. citizens may be added to the list up to five (5) days before date of visit, if space is available on bus.
- c. Visitors should assemble at the specified time and place for badging. Badging may be done at DOE Headquarters, 2753 South Highland Drive, visitors' hotel, or at the Mercury Badge Office at the NTS.

Person arranging visit should provide name of hotel for point of contact while staying in Las Vegas.
- d. When being badged, U.S. participants will be required to attest to their U.S. citizenship and to provide their driver's license or other personal identification for admission to the Test Site.
- e. Foreign nationals will be required to show passports at time of badging.

IV. TRANSPORTATION:

1. In some cases, bus transportation will be arranged and paid for by DOE for organizations not arriving in their own or privately chartered buses. However, most organizations will be asked to arrange and pay for their own transportation for visits to the NTS directly with LTR, Inc., Post Office Box 42130, Las Vegas, Nevada 89104 (702) 384-1230.

Groups should provide the Office of Public Affairs with the name and address of the person to whom the bill should be sent for referral in case of an error in billing.

2. Organizations arriving in their own or a chartered bus may use their bus for the visit; however, the driver must be included in the access list and the required badging information provided.

3. A round trip visit from Las Vegas to and on the Test Site, which is larger than Rhode Island, takes about 250 miles of travel and requires ten to twelve hours. Groups usually leave Las Vegas between 7:00 and 7:30 a.m., and return between 5:00 and 6:00 p.m. This time can be shortened by deleting some major stops.

V. OTHER:

1. Luncheon at one of the NTS cafeterias must be paid for by each individual. There will be no group billing.
2. Warm weather/cold weather casual or field type clothing should be worn. Adequate foot protection is necessary for rough terrain. Sandals should not be worn. Persons wearing sandals will not be permitted to enter underground facilities.
