All NRC records, including, but not limited to, phone notes and records, memos, meeting notes and summaries, reports, legal and regulatory bases, internal and external communications, technical information, pertaining to the following: Documents relating to the submittals by International Uranium (USA) Corporation (White Mesa Mill, Docket No. 40-8681) dated December 15 and 18, 2000 (Supplemental Information Regarding April 12, 2000, Amendment Request to Process an Alternate Feed Material from W.R. Grace at the White Mesa Uranium Mill). The Dec. 18 letter references "NRC's request that IUSA provide specific practices that would be applied to management of the material . . . this procedure is intended to be applied to acceptance of any alternate feed material(s) which IUSA determines to potentially contain levels of thorium that require special procedures."

Request is for the records that deal with the NRC request for the "special procedures" for high thorium content material and the NRC review and approval of IUC's special procedures for High Thorium Content Material. This would involved both license amendments 17 and 18 to License No. SUA-1358.
