Dear Dr. Rowe:

This letter refers to the inspection conducted on April 14-17, 2003, at the National Bureau of Standards Reactor (NBSR) facility. The purpose of the inspection was to verify the implementation of interim compensatory measures (ICMs) and the successful incorporation of the ICMs into the security and safeguards program at your facility. The ICMs were proposed in your letter to the NRC dated September 24, 2002 and imposed by the NRC through a Confirmatory Action Letter dated October 28, 2002.

The enclosed report presents the results of that inspection. Various aspects of your safety and security programs were inspected including selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. Based on the results of the inspection, no significant safety issues were identified.
