Subject: Completion of NRC Order (EA-03-038) Requirements Related to Fitness-For-Duty Enhancements Applicable to Nuclear Facility Security Force Personnel for the Davis-Besse Nuclear Power Station, Unit 1

Ladies and Gentlemen:

By letter dated April 29, 2003, the Nuclear Regulatory Commission (NRC) issued an Order for Compensatory Measures Related to Fitness-For-Duty Enhancements Applicable to Nuclear Facility Security Force Personnel (henceforth, the Order). On June 4, 2003, and July 24, 2003, the FirstEnergy Nuclear Operating Company (FENOC) submitted responses (Serial Letter Numbers 2963 and 2975) to the Order for the Davis-Besse Nuclear Power Station (DBNPS) Unit 1. On October 23, 2003, the NRC staff granted a relaxation regarding work-hour limitations for security force personnel that allows licensees to exclude shift turnover time from the group work-hour average, and allows licensees to use the 60-hour per week average during the period of the actual conduct of force-on-force exercises.

In accordance with Section III.C.2 of the Order, this letter provides notification that actions taken by the DBNPS to fully comply with the Compensatory Measures, as described in the DBNPS submittals identified above, have been completed. While the DBNPS conservatively includes shift turnover time in the group work-hour average at the present time, changes to applicable programs are being evaluated based upon the new information contained in the October 23, 2003 letter.


