Dear Mr. Mallay:

By letter dated October 10, 2003, you submitted an affidavit dated October 10, 2003, executed by you, that requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.790:

Reload Analyses for CR-3 Cycle 14 Using the BHTP CHF Correlation; General Analysis Process; Impact of Utilizing the Conservative CHF Calculation Adjustment for Local Coolant Qualities Less than the Lower Quality Applicability Range Stated in the BHTP Topical Report; Margin Remaining in the Analyses; NRC Review Visit, October 2003

A nonproprietary copy of this document has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (a) The information reveals details of FANP's [Framatome ANP's] research and development plans and programs or their results.
- (b) Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.

- (d) The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for FANP in product optimization or marketability.
