Subject: Inspection No. 50-219/89-05

This refers to the routine inspection conducted by Mr. George Napuda of this office on February 6-14, 1989, at Oyster Creek Nuclear Generating Station, Forked River, New Jersey, of activities authorized by NRC License No. DPR 16, and discussions of our findings held by Mr. George Napuda with you and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors of ongoing work.

Within the scope of this inspection, no violations were observed. However, we are concerned about the extent of problems with drawing controls identified by your staff and by recent NRC inspections; and, the magnitude of your project to correct these deficiencies (see paragraph 2.3.5 in the enclosed report). Therefore we request that you provide a written schedule, including milestones, of your Configuration Management-Drawing Controls Project to this office within thirty days and updates thereafter as necessary.

The response requested by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

Your cooperation with us in this matter is appreciated.
