Pursuant to your request, I am writing to request the inactivation of sealed source certificate No. NR-569-S-101-S, for Model No. RSNP-AU Gold-198 Seeds that were formerly manufactured and distributed by Radiation, Safety & Nuclear Products, Inc.

Our Radioactive Materials License No. UT18000014, issued by the Utah Division of Radiation Control was terminated, at our request, on December 8, 2000. (Copy enclosed.)

You have requested the following additional information:

1. The total number of products sold.

This number could be generated, but only after considerable time and research in our archived records. A close estimate would be as follows:

15 years x 50 weeks/year x 100 seeds/week (Conservative average) = 75,000 seeds

2. The number of products still in use - NONE
3. The services that will still be provided to users of the product - NONE
4. A commitment that the registration certificate holder will no longer commercially distribute the products - DONE. We have no intentions of renewing our manufacturing/distribution license.
5. Verification that no changes were made to the product since its initial registration or last amendment - DONE. No changes were ever made during the duration of our manufacturing/distribution activities.


