BASALT WASTE ISOLATION PROJECT INTERNAL AND EXTERNAL AUDIT SCHEDULE

Enclosed is the updated audit schedule for the period from January 1, 1987, through December 31, 1987.

The updated schedule shows when the audits were scheduled, and when they were performed, or will be performed.

Previously, separate audits were scheduled for Rockwell Hanford Operations (Rockwell), Westinghouse Hanford Company (WHC), and Boeing Computer Services Richland, Inc. (BCSR), in June, July, and October, respectively. However, as you are aware, WHC with BCSR as its subcontractor, was recently awarded the operations contract for the Hanford Site. Transition from Rockwell, the current contractor, officially takes place on July 31, 1987. As a practical matter this transition will be continuing for several months beyond this date. Consequently, what were originally scheduled to be three audits, one for each of the above noted contractors have been rescheduled into two audits of WHC, one in August and another in October. The combination of these two audits will cover all of BWIP work performed by the new Westinghouse Hanford Corporation. Similarly, the audit on Morrison-Knudsen Company, Inc., is rescheduled for December 1987.

Scheduling is intended to leave room for performance of unscheduled audits as unanticipated needs are recognized. While the Quality Systems Division attempts to provide three to four weeks advance notice of scheduled audits, special audits inserted into the schedule may be performed with substantially less formal notice. In such instances, direct communication will be used.
