Mr. Von Till,

I am writing in regards to the Split Rock Mill Site, located near Jeffrey City, Wyoming. I live in the Red Mule Subdivision and have been contacted by Western Nuclear to arrange a settlement, of sorts. Following are some questions that I would like to have answered.

I have requested from Mark Thiese, State of Wyoming DEQ/Lander, copies of the recent test well results from the monitoring wells in the southwest valley. Mr. Thiese informed me that he has not received test results from WNI since 1999. (See enclosed copy of email). Following is a list of monitoring wells that I would like to see results from, if you have information on these wells, please send soil and groundwater results. I would like test results for wells listed below:

There are two new monitoring wells, drilled in January of 2002, which we do not have the sample numbers for. Please send results for these wells, also.

Next are some questions that I would like you to answer, as best you can.:

1. Of the samples taken from monitoring wells in the southwest valley, has there been an increase in the site derived constituents? If so, what constituents are of concern to the NRC?
2. Has WNI been informed of this, and on what date were they informed?
3. Has the NRC and/or EPA confirmed contamination of the aquifer by WNI? If so, what specific constituent(s) were above contaminant level?
4. What steps need to be taken by WNI in order to close the contract on the Split Rock Mill site in regards to private property and domestic water wells?
Is there a time frame involved as to when WNI must complete the requirements?
5. Does WNI have to comply with the Wyoming water standard or EPA standards? What was the initial date of water testing for the Split Rock Mill site?
6. Does the NRC and/or EPA prefer land ownership as to an alternate water system for Red Mule residents?
7. Has WNI submitted a new plan since 1999? Does it differ from original plan?
8. If WNI becomes out of compliance, due to new regulations, what course of action is taken by the NRC and/or EPA?

Please respond as quickly as possible, and as stated before, you can mail the test results and responses to the above address.
