Robert Baca:

Bob Marshal and Dave Lincoln interacted with the NMSS TDOCS/CDOCS team from Tuesday morning (9/24/96), when they arrived, until about 12:30 p.m. on Friday (9/27/96) when they departed. The entire time (except for the meeting with the PDC on Thursday morning) was spent resolving issues as listed on the following agenda and answering the NMSS team's questions regarding program logic and structure, installation and compile issues, and custodial functions. The NRC team had made considerable progress in installing the executable program and compiling the source program. With that experience, the team was able to gain maximum benefit from the CNWRA staff's interaction with them. The interactions went well and were quite productive. However the resolution of the submit issue, that has been pending since March, was of such a nature that I am concerned that the support could not have made that resolution long before this visit.

Aaron DeWispelare, arrived after 1:00 p.m. on Wednesday, 9/25/96. He spent part of Wednesday afternoon with the Team as they worked and then gave the presentation for the two representatives from the NRC Professional Development Center (PDC) who will be responsible for future training of NRC staff in the use of the application.

The updated tape with the latest document database was not provided during the visit as originally proposed by CNWRA. In a telephone conversation with A. DeWispelare today, he said that it would be more convenient for CNWRA to load some more documents and prepare the tape by the end of this week. He assured me that it would be done without any contractual problems. That being so then it is acceptable to prepare the tape by Friday October 4, 1996 and express mail it to NRC.

Another outstanding issue is the testing of the synchronization capability between the two systems. It is my understanding that R. Marshall and A. DeWispelare will be discussing this issue with you.

The schedule for the meeting between the NMSS TDOCS/CDOCS Team and the CNWRA team follows. This is an updated schedule reflecting the actual times that CNWRA arrived and departed and events during the time. Note that with respect to your letter to R. Wescott of 9/26/96, there were not "parallel sessions, one for the technical staff, and the other for the system operators." if by technical staff you were referring to the Division of Waste Management technical staff.

Document submission in the operational TDOCS application (NMSS2) is not operational (it has been determined that the document submit operation of the upgrade CDOCS is also not operational). A known problem since March 1996. As last reported, we can "submit" text documents, but cannot "submit" either tif or WordPerfect documents. Our last information about this problem indicated that CNWRA appears to have a similar problem on one of their workstations. CNWRA has made suggestions about checking file and directory permissions and these checks have been completed with no correction of the problem. These problems will need to be rectified during CNWRA visit.

Chapter two documentation...

NRC has two sets of WP documents for Chapter 2, neither of which corresponds in page numbers, etc. with the printed documentation that was provided NRC by CNWRA. In one case, WP keeps claiming that there is not enough room in a temporary directory to retrieve text -- even though the document in this case is the smaller of the two.

What is 'print_report'?

Apparently the print button builds a string and expects to run against a script/executable of this name. No such file exists on either NMSS2 nor NMSS24. How should this be set up? Where is it documented? Should it have been part of the install files?

Why is the Solaris client compiling to 1/9 the size of the one from the

distribution tape?

In conference on 09/19/96, a problem with trying to stop the server using the supplied routines (da_kill and kill_da) was mentioned and the CNWRA acknowledged knowing there to be a problem. This issue needs to be resolved.
