To date, there. are no subsequent drafts and/or revisions pending receipt of comments from Affected Parties.
  - Copies of reports in the DOE Basalt Waste Isolation Division's possession, will also be forwarded under separate cover.

As part of the Consultation process for the Hanford Site Cultural Resource Program, as well as the activity-specific BWIP Environmental Review (BER), the Affected Tribes will receive copies of all future archaeological and historical reports.
