SUBJECT: SUMMARY OF THE OCTOBER 1, 2003, PUBLIC MEETINGS TO DISCUSS FIRSTENERGY'S PLANS TO ADDRESS SAFETY CONSCIOUS WORK ENVIRONMENT AND SAFETY CULTURE

On October 1, 2003, the Nuclear Regulatory Commission (NRC) held a public meeting at the NRC Region III office in Lisle, Illinois. The meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss the licensee's plans to address safety conscious work environment and safety culture.
