- (a) A general license is hereby is med to any physician, clinical Oberatory, or hospital to receive, acquire, possess, transfer or use, for any of the following stated tests, in accordance with the provisions of paragraphs (b), (c), (d), (c), and (f) of this section, the following byproduct materials in propachaged units:
- (1) Iodine-125, in units not exceeding 10 microcuries each for use in vitro clinical or laboratory tests not involving internal or external administration of hyproduct material, or the radiation therefrom, to human beings or animals,
- (b) No person shall receive, acquire, possess, use or transfer byproduct material pursuant to the general license established by paragraph (a) of this section until he has filed Form AEC-183, "Registration Certificate In Vitro Testing with Byproduct Material Under General License", with the Directorate of Licensing, Materials Branch, U.S. Atomic Energy Commission, Washington, D.C. 20545, and received from the Commission a validated copy of Form AEC-483 with registration number assigned.
