Eli,

This is a response to your question regarding how distribution of products from the fabrication facility of Systems Sensors, located in a maquiladora area should be addressed in the sealed source and device (SSD) registration. The following is not an interpretation binding on the Commission, but does reflect the NRC staff's view on the regulation.

I have consulted with the NRC experts for international questions. The conclusion is that the special status of the maquiladora applies to import/export issues only regarding US Customs and its reporting requirements; and that the special status does not apply to NRC requirements. Therefore, Systems Sensors should amend its SSD registration certificate NR-0547-D-101-E to include the fabrication facility in Juarez, Mexico.

Please note that the information regarding fabrication, quality assurance, and record keeping that you have provided in your e-mail dated Sept. 8, 2003, should be essentially sufficient for the NRC to amend the certificate. However, for distribution from the Juarez location, you should emphasize (i.e. reference or enclose) the final QA/QC procedure including the sampling size for the production lots. We intend to reference in the registration certificate the final checks that Systems Sensors will implement for the distribution lots from Juarez.

Please note that we do need a formal request from Systems Sensor for the amendment, your e-mail is not sufficient. The request should come from Systems Sensor with their signature and should present the information that was in your e-mail plus the additional information I described above. There is no fee for an amendment.

- > \* All QC/QA records for elements referenced in the application for >device registration or required by 10 CFR 32 will be available for >inspection in St. Charles.
- > \* Records which have not been forwarded at the time of an inspection >will, upon request, be made available in a timely fashion.
- > \* All commitments made in support of the application for device >registration shall apply to products manufactured in Juarez.
- > \* Product manufactured in Juarez is completed, labeled and packaged in >Juarez.
- \* System Sensor will perform quarterly audits of the Quality Control
   >program at its Juarez, Mexico facility. Records of these audits shall be
   >retained for inspection at the St. Charles, IL facility.
   >Product made in the System Sensor maquiladora currently must be shipped to
