SUBJECT: REQUEST FOR CHANGES TO ASSIGNMENTS OF NRC STAFF AS PROGRAM ELEMENT MANAGERS AND PROJECT OFFICERS FOR THE CNWRA CONTRACT

As part of implementing the Vertical Slice Approach for the High-Level Waste (HLW) Repository Program, the HLW Management Board has reviewed the Nuclear Regulatory Commission staff assignments for program element managers (PEMs) and project officers (POs) for the CNRWA contract. Previously, the Board had approved NRC team leads for each of the 10 Key Technical Issues (KTIs). Consistent with this approach, the Board has decided that each KTI team lead should also be the PEM for the respective CNWRA KTI work, as identified in the CNWRA's February 1996 Operations Plan. The Board also decided that project officers would be eliminated, but with one exception listed on the attachment. The new NRC PEMs and one PO are attached. Please take the necessary actions to have the CNWRA contract modified to make these new assignments effective immediately. Furthermore, specific training for managing the CNWRA contract, including any revisions to how we are planning to streamline management procedures, should be conducted as soon as possible for all PEMs and the one PO. If you have any questions regarding this request please discuss them with me or Robert Johnson of my staff.
