SUBJECT: REVIEW OF CENTER FOR NUCLEAR WASTE REGULATORY ANALYSES OPERATIONS PLANS FOR FISCAL YEAR 1996 - 1997

The Operations Plans from the Center for Nuclear Waste Regulatory Analyses (CNWRA) was distributed, under separate cover, to the Division of Waste Management Program Element Managers (PEMs) and Project Officers (POs) on Wednesday, August 9, 1995. The PEMs and POs should review these plans before the CNWRA's briefing on the Operations Plans scheduled for Monday, August 14, 1995. During the briefing, the PEMs and POs will have an opportunity to raise questions, if necessary, based on their reviews.
