We have reviewed the corrective actions as described in your letter, and we have no further questions at this time. Your corrective actions will be examined during a future supplemental inspection using Inspection Procedure 95001 in accordance with the Action Matrix (Exhibit 5) of NRC Manual Chapter 0305. Current planning has targeted the first part of December 2003, for this IP 95001 inspection.
