

Inspection (NIS-1 Report)

On January 9, 2003, Vermont Yankee Nuclear Power Station (VY) submitted to the NRC the 2002 Form NIS-1 Owner's Summary Report for In-service Inspections¹. The report described the in-service inspections performed during the period May 21, 2001 through October 25, 2002. As a result of internal reviews, it was recently identified that the NIS-1 report warranted revision. Accordingly, the letter hereby transmits a revised page 18 (page 18 of 20).
