Dear Mr. Brown:

The purpose of this modification is to: (1) increase the ceiling amount for the period August 1, 2003 through October 20, 2003, in the amount \$933.10 as a result of wage determination no. 1994-2103, Rev. 30, dated June 3, 2003, which was effective August 1, 2003, (2) extend the period of performance from October 21, 2003 through July 31, 2004, hereby increasing the ceiling in the amount by \$43,179.94, and (3) provide funding in the amount of \$11,300. Accordingly, the task order is modified as follows:

The second paragraph of the definitization letter is hereby deleted in its entirety and the following is substituted in lieu thereof:

"The period of performance for Task Order No. 6 is October 21, 2002 through July 31, 2004, at a total estimated cost of \$99,065.58. Funds in the amount of \$66,252.64 are hereby obligated for the performance of this task order. The obligated amount shall, at no time, exceed the task order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."


