The purpose of this modification is to provide incremental funding in the amount of \$651,656 to fully fund the option year under the subject contract. Accordingly, the following change is hereby made under the contract:

1. Section B.3, "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUNE 1988) ALTERNATE I (JUNE 1991)," paragraphs (e) and (f) are DELETED in their entirety and SUBSTITUTED with the following in lieu thereof:

"(e) The amount obligated by the Government with respect to this contract is \$2,889,656 of which the sum of \$2,726,091 represents the reimbursable costs, and of which \$163,565 represents the fixed fee."

"(f) It is estimated that the amount currently allotted will cover performance through September 24, 2003."

A summary of obligations for this contract, from award date through the date of this action, is given below:
