

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to exercise option 1 of this contract (CLINs 4, 5 & 6). Accordingly, CLINs 4, 5 & 6 are hereby exercised. As a result, the total amount of this contract is increased by \$215,135.04 from \$41,117.60 to \$256,252.64. \$215,000 in funding is hereby obligated as shown in block 12 above. Consideration and Obligation clauses are added attached hereto to illustrate the allocation of the obligated funds among the CLINs. The term of the contract is extended to November 30, 2004 per the attached Duration of Contract clause. In addition, Mr. Robert Miller at 301-415-6851 is hereby designated as the Project Officer at Section C.16. Mr. Dennis Turner will remain the alternate Project Officer to act for the Project Officer in his absence.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

B.1 CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE (JUN 1988)

The firm fixed price of this contract is \$221,977.64.

B.2 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988)

This clause currently applies to CLINs 2,3, 5 & 6.

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$34,275. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is 34,139.96. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

C.4 DURATION OF CONTRACT PERIOD (MAR 1987)  
ALTERNATE 2 (MAR 1987)

This contract shall commence on 10/1/03 and will expire 11/30/04.  
The term of this contract may be extended at the option of the Government for an additional three one-year periods.
