SUMMARY

By application dated September 29, 2003, as supplemented on October 7, 2003, Neutron Products, Inc., requested an amendment to Certificate of Compliance No. 9102 for the Model No. NPI-20WC-6 package. Neutron Products, Inc., did not request any design changes to the package. The package design drawings were revised to reflect administrative changes. Neutron Products, Inc., submitted updated operating and maintenance procedures for the package. The certificate has been renewed for a five year term.

EVALUATION

Drawing No. 240116, Revision No. G, replaces Drawing No. 240160, Sheet 1 of 2, Rev. None and Sheet 2 of 2, Rev. A. The administrative changes made to Drawing No. 240116, Revision No. G, were minor. The inside length of the wooden crash shield was corrected from 30 inches to 29.5 inches. The dimension of the lid of the wooden crash was changed from 15 inches to 12 inches. Tie downs were added to Section F-F. The designation of serial number OP-3 and OP-4 were removed.

The staff reviewed the documents referenced in the certificate and determined that the documentation was available and complete. The staff also reviewed the updated operating and maintenance procedures for the package and found them to be adequate.

CONCLUSION

The certificate has been renewed for a five year term that expires on November 30, 2008. This change does not affect the ability of the package to meet the requirements of 10 CFR Part 71.
