MILESTONES A3/A4

Enclosed you will find regulatory requirement topics E17 and E36 (respectively entitled " Adverse Condition--Geochemical Processes" and "Structure, Systems, and Components Important to Safety -- Protection Against Natural Phenomena and Environmental Conditions") to be used to demonstrate fulfillment of element/subelement milestones A3 and A4 (collective short title: "Finalize PASS structure through WSE&I Process Block #15"). (It should be noted that these two regulatory requirement topics will also be used to demonstrate fulfillment of the so-called "proof-of-system" milestone R7.)

These two regulatory requirement topics are being resubmitted in accordance with our letter of October 28, 1988 requesting that the Center select regulatory requirement topic examples sufficient to demonstrate the necessary automated data processing (ADP) features of the Program Architecture Support System (PASS), as called for by the requirements of the A3/A4 milestones.

It is requested that you review and comment on the subject milestones as they apply to the desired ADP features of PASS. Mike Lee (4A18, x20421) will be coordinating the review.
