SUBJECT: APPROVAL OF REVISION TO PERFORMANCE ASSESSMENT ELEMENT
SECTION OF THE CNWRA FY93-94 OPERATIONS PLANS FOR THE
DIVISION OF HIGH-LEVEL WASTE MANAGEMENT, REV.3, CHG. 4

On July 8, 1993, the NRC requested (letter from B. Meehan to W. Patrick) the Center for Nuclear Waste Regulatory Analyses (CNWRA) to add a new subtask to the Performance Assessment (PA) Element Section of the CNWRA FY93-94 Operations Plans (OPS) to address technical support to the NRC related to the National Academy of Sciences (NAS) Committee meetings on the Technical Bases for the Yucca Mountain Standard. In response to this request, on July 27, 1993, the CNWRA submitted change pages to the FY93-94 OPS which describe the technical support for activities regarding Health-Basis of Standards. The CNWRA transmittal letter (letter from W. Patrick to M.L. Scott) indicated that the activities related to Institutional Controls, Human Intrusion, and Natural Disruptive Events will be addressed in the FY94-95 OPS.

Based on our review, the Performance Assessment staff finds the proposed change pages to the OPS to be acceptable.
