Troxler portable moisture density (MD) gauge containing 8 millicuries of cesium-137 and 40 millicuries americium-241 was lost when it fell out of a moving pickup truck. NRC not notified until several hours after the gauge was known to be missing. The gauge was found, same day, intact.

Remarks:

5/3/02 - Tech failed to lock the chain securing the gauge transport case, and may not have properly closed the tailgate. When he arrived at the job site, the technician discovered that the tail gate was opened, and the transport case containing the MD gauge was missing. The licensee notified Region III and the NRC Operations Center in the afternoon of 5/3/02. NRC notification canceled because gauge found by PD.

Alt & Witzig Engineering: On 7/5/02, the Region sent a "choice" letter to the licensee. If he does not want to come in to discuss his proposed SL III violation of 10 CFR 71.5(a) and 20.2201(a)(1) and proposed \$3000 CP (described in lost source policy), the Region will prepare NOV and CP package. The Panel discussed the necessity to wordsmith the CP portion of the package.
