SUBJECT: STATUS OF RES RULEMAKING ACTIVITIES

Attached is the report on the status of rulemakings underway in the Office of Nuclear Regulatory Research.

Attachment 1 highlights rulemakings for which a major milestone has been achieved since the last reporting period or rulemakings with potential areas for concern (schedule slippages). Background information on all ongoing RES rulemakings, including those in Attachment 1, can be found in Attachment 2. This information includes the current status of the rule, timetable, and reasons for slippages, if any.

Please note that timetable scheduled action dates reflect EDO-approved due dates. If a slippage is anticipated by a task leader, that date is included in parentheses beside the EDO-approved milestone. These task leader best-estimate dates do not necessarily indicate division or office approval. It should also be noted that item B in Attachment 1 is a rulemaking with an anticipated schedule slippage of greater than 60 days and is currently under investigation by the Regulation Development Branch.

An additional part of the slippage is that associated with the time needed to interact with the staff to resolve public and staff comments prior to preparation of the final rule.

The staff has been revising the proposed Rule and Regulatory Guide 1.155 (SI 501-4) to respond to CRGR comments and NRR management directives. Discussions and revisions resulting from such considerations are continuing.

NUMARC/NUGSBO staff met with E. Beckjord, T. Speis and B. Sheron on July 24, 1987, to discuss the status of NUMARC's initiatives and items requiring further resolution. The result of that meeting was to encourage the staff to meet with NUGSBO for resolution of outstanding issues.

The staff has been meeting with NUGSBO throughout August 1987 to resolve differences on the definition of Alternate AC (AAC) power sources, use of Emergency Diesel Generators (EDGs) as AAC sources, etc. NUGSBO staff has been revising its guidelines and procedures for coping with Station Blackout (SBO) to incorporate the staff's definitions, technical positions and other requirements. Much progress has been made; more work remains. The common goal is to have NUGSBO develop a suitable reference report which can then be referenced in RG 1.155 in a manner similar to current RG practices which refer to industry Codes and Standards and find them an acceptable way to meet regulatory requirements. It is projected that the staff/NUGSBO negotiations will extend into September 1987, before all differences are ironed out.

The goal remains to submit the A-44 package to the EDO as soon as possible. However, continuing discussions with NUGSBO (which are resulting in an improved product), the need to reassess the package in light of the recent court ruling on the backfit rule, and finalizing the wording in the Rule and RG (to be provided by NRR) do not support an August 1987 submittal to the EDO. A late September 1987 submittal appears more realistic; a revised schedule is under development.
