### **NRC TO HOLD PUBLIC MEETING ON FARLEY NUCLEAR STATION LICENSE RENEWAL**

The U. S. Nuclear Regulatory Commission staff will hold two public meetings on January 8<sup>th</sup> in Dothan, Alabama, on the environmental review related to the application of Southern Nuclear Operating Company (SNC) to renew the operating licenses for the Joseph M. Farley Nuclear Plant, Units 1 and 2 (FNP). Members of the public are invited to attend and comment on environmental issues the NRC should consider in its review of the proposed license renewal.

The meetings will be held at the Quality Inn in Dothan. There will be two similar sessions, one in the afternoon at 1:30 and one in the evening at 7:00. In addition, the NRC staff will host informal discussions one hour prior to each meeting. NRC staff members will be available to answer questions and provide additional information about the process during those informal sessions, but no comment submittals on environmental issues will be accepted at that time.

All are welcome to attend. For planning purposes, those who wish to present oral comments at the meeting may register by contacting Jack Cushing of the NRC by telephone at 1-800- 368-5642, Extension 1424, or by email at [FarleyEIS@nrc.gov](mailto:FarleyEIS@nrc.gov) no later than January 2, 2004. Interested persons may also register to speak before the start of each session. Individual comment time may be limited by the time available.

The meetings will include an overview and NRC staff presentation on the environmental process related to license renewal, after which members of the public will be given the opportunity to present their comments on what environmental issues the NRC should consider during its review.

Under NRC regulations, the original operating license for a nuclear power plant is issued for up to 40 years. The license may be renewed for up to an additional 20 years if NRC requirements are met. The current operating licenses for the FNP will expire on June 25, 2017, and March 31, 2021, respectively. SNC submitted its application for license renewal on September 15<sup>th</sup> of this year.

The application is available for public review at the Houston Love Memorial Library, 212 West Burdeshaw Street, Dothan, Alabama, and at the Lucy Maddox Memorial Library, 11880 Columbia Street, Blakely, Georgia. It is also available in the NRC Public Document Room at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland, on the Internet at [www.nrc.gov/reactors/operating/licensing/renewal/applications/farley.html](http://www.nrc.gov/reactors/operating/licensing/renewal/applications/farley.html) and from the Publicly

An existing NRC document, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants," (NUREG-1437), assesses the scope and impact of environmental effects that would be associated with license renewal at any nuclear power plant site. The NRC staff is gathering information at these meetings for a supplement to the generic environmental impact statement that will be specific to FNP. It will contain a recommendation regarding the environmental acceptability of the license renewal action.

At the conclusion of the information-gathering process, the NRC staff will prepare a summary of conclusions and significant issues and will send a copy to interested persons who participated in the scoping process. The summary will also be available for public review at the Houston Love Memorial Library and at the Lucy Maddox Memorial Library, and accessible electronically through the NRC Public Electronic Reading Room at [www.nrc.gov/NRC/ADAMS/index.html](http://www.nrc.gov/NRC/ADAMS/index.html).

The NRC staff will then prepare a draft environmental impact statement supplement for public comment and will hold a public meeting to solicit comments. After consideration of comments received on the draft, the NRC will prepare a final EIS supplement.

Members of the public may also submit written comments on the scope of the FNP-specific supplement to the generic environmental impact statement.
